- 1. Memorandum of Understanding (MoU) was signed between DBT-APSCS&T CoE for BRSD, Kimin and Dibrugarh University, Dibrugarh, Assam on 5th April, 2024 aimed at establishing Academic and Research collaboration between Dibrugarh University, Dibrugarh and DBT-APSCS&T CoE for BRSD, Kimin and recognition of DBT-APSCS&T CoE for BRSD as an affiliated institute of Dibrugarh University for Ph.D. research and facilitating eligible scientists of the CoE with Co-guideship towards guiding prospective Research Scholars of both the institutes.
- 2. The Capacity Building Commission (CBC), Government of India has identified and adopted DBT-APSCS&T CoE for BRSD, Kimin, Arunachal Pradesh under its initiative "Amrit Gyan Kosh" as one of the cases under Phase-I. This initiative of CBC is aimed creating a Knowledge Bank (Amrit Gyaan Kosh) which shall be a repository of case studies, and teachable resources (in audio and visual format). These cases will be used across the training ecosystem of the Government of India and will be spanned across various themes and sectors.

As per the recommendation of the DBT-Technical Evaluation Committee (TEC), DBT-APSCS&T CoE for BRSD, Kimin has submitted the Revised Project Proposal entitled "Integrated Ex-Situ Conservation, Characterization and Sustainable Utilization of Genetic Diversity of RET and Economically Important Plant Species of Arunachal Pradesh" to the Department of Biotechnology (DBT), Government of India on 22nd April, 2024 for consideration and securing sanction for implementation of the project.
- 4. As part of the "Amrit Gyan Kosh" initiative by the Capacity Building Commission, an online meeting was conducted by CBC on 26th April, 2024 wherein Dr. Chandan Kumar, Assistant Professor, TERI School of Advanced Studies, New Delhi, designated as Author for the Case study had interacted with Project Director and Scientists of the CoE. The Authour was briefed on genesis of establishment of the DBT-APSCS&T CoE for BRSD, Kimin and the achievements, progress made by the CoE till date.
- 5. In-house Review Meeting was conducted on 29th April, 2024, wherein Dr. Pompi Das, Scientist-B presented the progress made by the Microbial Biotech. Lab and emphasized the upcoming projects and plan of R&D activities to taken up.
