#### 1. Introduction

For an Arunachal Pradesh State Government-sponsored project and for analysis of Data, APSCST invites bids from reputed manufacturers/authorized distributors/dealers for the supply, installation, and commissioning of Servers, desktops, and monitors.

Bidders are advised to study this tender document carefully before submitting their proposals in response to this Notice. Submission of a proposal in response to this notice shall be deemed to have been done after careful study and examination of this document with full understanding of its terms, conditions, and implications.

#### Scope of Work

- a) The bidder is required to supply and install a server to the Centre of Excellence for Science Technology Innovation and Research (CoE-STIR) at Arunachal Pradesh State Council for Science and Technology (APSCST), Itanagar, as per the specifications and conditions specified in the different parts of this Tender document.
- b) Installation & configuration of the server.
- C) The bidder is required to supply and install four numbers of desktops to the Centre of Excellence for Science Technology Innovation and Research (CoE-STIR) at Arunachal Pradesh State Council for Science and Technology (APSCST), Itanagar, as per the specifications and conditions specified in the different parts of this Tender document.
- d) The bidder is required to supply and install seven monitors (01 WQHD and 06 FHD Monitors) to the Centre of Excellence for Science Technology Innovation and Research (CoE-STIR) at Arunachal Pradesh State Council for Science and Technology (APSCST), Itanagar, as per the specifications and conditions specified in the different parts of this Tender document.
- e) The entire Installation, commissioning, and hands-on Training to the officials of APSCSTT must be carried out by an OEM-certified partner or OEM-certified engineers (documentary proof needs to be given at the time of installation).
- f) The successful bidder shall carry out the work strictly as per specifications mentioned in various sections of this tender document to the satisfaction of the indenting department.
- g) Workmanship and material used should be of the best quality.



h) All software licenses for servers must be perpetual in nature. All necessary software & firmware upgrades must be intimated in time and provided free of cost during the entire warranty / AMC period.

# 2. Notice Inviting Quotation

The below-mentioned Specification tables should be submitted with a filled-in compliance column as part of the technical proposal by the bidders.

The bidder and OEM will be responsible for the offered system should be the latest model of the vendor being supplied worldwide. If APSCST finds that the offered model is End of Life (EOL) or End of Support (EOS) or both, then APSCST authority has the right to disqualify the bidder.

#### **OEM Criteria:**

- 1. OEM(s) must have a sales and support office in India.
- 2. The Server OEM(s) must have a spare depot in India for the items mentioned in this tender (details of spare locations to be provided).
- 3. The Server OEM should have a local Service Center in the Eastern Part of India.
- 4. The specified unit shall be based upon standard components and proven technology and adhere to industry-established standards.
- 5. Firmware/software upgrades are to be provided by the OEM free of cost during the warranty and AMC Period. Undertaking from OEMs to be provided on their letter head.
- 6. The server and its components shall be the latest but field-proven and shall not be End-of-Life/Outdated; the same shall have to be supported by the concerned OEM for at least 3-year periods from the date of installation.
- 7. The server shall have a minimum 3-year OEM warranty (NBD).

# Eligibility Criteria of bidder(s):

- 1. The Bidder should be a Manufacturer/authorized distributor/dealer of the respective product solution OEM (Manufacturer Authorization Form).
- 2. The bidder shall furnish a non blacklisting certificate that the firm has not been blacklisted in the past by any government/Private institution. The bidder/supplier has to give an affidavit on non–judicial stamp paper of Rs. 50/- that there is no vigilance/CBI case pending against the firm/supplier and the firm has not been blacklisted in the past by any Government or Private Organization.
- 3. If the bidder is an ISO certified Company, then documentary proof should been closed.
- 4. Penalty for delay in resolution If the selected bidder/OEM does not resolve any technical issues within the time frame from the response time, a penalty of 0.5%



of the total cost per day (maximum 7 days) will be charged and deducted from the amount payable to the bidder. For delay beyond the stipulated period, the entire PBG will be forfeited.

5. Delivery should be made by the successful bidder as FOR CoE-STIR, Itanagar.

# **Warranty and Support**

- 1. The server must have a minimum 3-year comprehensive on site OEM warranty.
- 2. All items quoted for the server must not have been declared as End-of-Support by the OEM anytime within the next five years.
- 3. Both the bidder and the OEM will be responsible for providing support to the system during the warranty period. APSCST, Itanagar must be able to contact both the bidder and the OEM for service during the entire warranty period. However, it should be clearly stated who will provide first-levelsupport.
- 4. The bidder must provide a write-up on its service and maintenance capability, and the escalation support matrix suggested for the Institute.
- 5. The OEM must provide details of the support structure and escalation matrix.
- 6. This is a critical infrastructure for the institute, so the institute reserves the right to reject any bid if the support infrastructure is not deemed to be adequate by the technical evaluation committee.

- The entire system shall be installed by an OEM-authorized partner or OEM-certified engineer as per the manufacturer's recommendations & instructions.
- Services of an authorized representative of Bidder or manufacturer for supervision of installation, connections, testing, & adjustments shall be provided.

# **Testing & Commissioning:**

Under the supervision of the manufacturer's representative entire system functions, operations, and protective features shall be checked & pre-set to ensure compliance or specifications.



- Test the system as per recommendations & the test report needs to be submitted.
- In case of testing any shortfalls/faults, the same shall be rectified & test procedure shall be repeated to establish satisfactory performance.

# **Drawings & Manuals:**

If required, the following drawings & manuals/information shall be submitted in both hard and soft copy at appropriate stages & for handing over the system.

# **Conditions forming part of NIO**

- Price of the equipment to be quoted for FOR, APSCST only.
- The single bid systems should be followed for this NIT. Under this system, the bidder must submit their offer in sealed envelopes should be super scribed with NIQ enquiry no. and the name of the equipment quoted for.
- The bidder shall be required to deposit Rs. 25,000/- as EMD with the Bid, through Bank Draft/ Fixed Deposit Receipt/Bank Guarantee drawn in favour of 'The Director cum Member Secretary, APSCST' payable at Itanagar. Quotation submitted without the requisite amount of earnest money shall be rejected. The EMD to the unsuccessful bidders will be returned within one month from the date of placing of final order(s). However, no interest/penalty shall be payable to bidders if the return of EMD is delayed for any reason.
- The successful bidder shall be required to submit a Performance Bank Guarantee (PBG) equivalent to 5% of the quoted amount, in favour of the Director-cum-Member Secretary, APSCST, payable at Itanagar, within ten (10) days from the date of award of the contract. The submitted PBG shall remain valid for a period of three (3) years.
- The Bids will be opened in the presence of the bidders on the specified time and date. The
  bidder/their authorized agents who have responded to the quotation will be allowed to be
  present in the opening.
- Bids would be rejected for award if it determines that the bidder recommended for award has,



directly or through an agent, engaged in corrupt, fraudulent, collusive, or coercive practices in competing for the contract in question.

- The bids received after the deadline for submission of bids prescribed by the APSCST will be rejected, and such bids shall be marked as late and not considered for further evaluation
- The APSCST may, at its discretion, extend the deadline for submission of bids by amending the bid documents in accordance with the clause relating to Amendment of Bidding documents, in which case all rights and obligations of the APSCST and Bidders previously subject to the deadline will thereafter be subject to the deadline as extended. All the amendments will be updated through further notification.
- The original and all copies of the bid shall be typed and shall be signed by the bidder or a
  person or persons duly authorized to bind the bidder to the Contract. All pages of the bid,
  except for un-amended printed literature, shall be initialed by the person or persons signing the
  bid. Further, overwriting on documents, if any, should be supported by signatures.
- Issuance o bid documents should not automatically be construed that the bidder is considered qualified.
- The bidders may submit their duly sealed Bid by post or by hand at the address specified in the NIQ not later than the time and date specified therein.
- APSCST shall not be responsible for any delay, loss, or non-receipt of bid documents sent bypost.
- The APSCST Authority has the right to reject any bids on technical grounds without assigning any reason thereof.
- Prices shall be quoted in Indian Rupees.
- The imported equipment should be quoted by the authorized supplier/dealer. In this case, commitment to sales service for the period applicable should be clearly mentioned.
- Compliance sheet should indicate in detail of meeting up of specifications required. The bidder can mention the additional features that exist in quoted products, if any, separately.
- Payment shall be made after delivery, successful installation, commissioning, and submission
  of Bank Guarantee and on submission of the installation and warranty certificate, duly signed
  and stamped by the authorized representative of the user department.
- Taxes, if applicable, should be quoted separately; otherwise, it would be presumed that the
  quoted prices are inclusive of taxes.
- Prices quoted should be FOR, APSCST, Itanagar, inclusive of all charges required to make



the equipment functional to the satisfaction of the Institute.

- Delivery should be within the specified days mentioned in the Purchase Order. If the equipment/instruments are not delivered within the stipulated time, the supplier shall be liable to pay a penalty of 1% of the total order value for each delay of 10 days or part thereof, and the amount will be deducted from bill value.
- The suppliers will undertake warranty of equipment/instruments from the date of installation and shall have to mention the period of warranty in the bids clearly.
- The quotations must be valid for a minimum period of 90 days (three months) from the date of opening of the bids. No change in prices and no change in terms and conditions will be permitted.
- The supplier further warrants that the goods shall be free from defects arising from any actor omission of the supplier or arising from design, materials, and workmanship, under normal use in the conditions prevailing in India.
- The bidder should indicate clearly in their bid the pre-installation requirements. Subsequently, before the consignment lands in CoE-STIR, the bidder shall confirm that the pre-installation requirements are sufficient for the installation of the equipment.
- Free training shall be imparted to faculty/technical staff for operation, maintenance, and troubleshooting at the user/IT department of APSCST.
- The equipment should be supplied with manuals containing technical drawings, complete in all respects, to operate the system without having any problems.
- The bidder may submit the proprietary certificate for the item(s), if applicable.
- In a bid, either the Indian agent on behalf of the Principal/OEM or the Principal/OEM itself can bid, but both cannot bid simultaneously for the same item/product in the same bid.
- If an agent submits a bid on behalf of the Principal/OEM, the same agent shall not submit a bid on behalf of another Principal/OEM in the same bid process.
- APSCST reserves the right to purchase varying quantities of material, lessor more.
- In the process of evaluation, comparison of bids, APSCST reserves the right to reject any or all bids.
- The bidder should make arrangements for insurance of the equipment against all risks of loss
  or damage from the date of shipment till such time it is delivered at the APSCST site in case
  of Rupee/Foreign currency terms.
- The Director cum Member Secretary, APSCST shall be the final Authority for settlement of any dispute and his interpretation of any Clause/term/condition(s) of this document shall be final.
